

## **Bethel Village Council February 28, 2012**

The Council of the Village of Bethel, Ohio, met in special session in Council Chambers on Tuesday, February 28, 2012 at 6:00 p.m., with Mayor Ausman presiding.

Mayor Ausman delivered the invocation, followed by Mayor Ausman leading the Pledge of Allegiance to the American Flag.
